



# FEMINIST HUMANITARIAN NETWORK MEMBERS AT WOMEN DELIVER

## Lipi Rahman

Lipi Rahman has worked with NGOs to advance women's and girls' rights and end VAW since 2002. She is co-founder of Badabon Sangho, an organization that supports women, particularly vulnerable women to increase access to and control over land, property, and water-bodies; and climate justice for women and girls. Badabon Sangho has mobilized over 4,000 women and girls in 107 grassroots groups, providing legal support and training to support them to engage with local government on their rights. Lipi is an active member of national and international networks including the Feminist Humanitarian Network, and contributes to national-level advocacy campaigns.



#### Winnie Tumwine

Winnie Tumwine is the founder and Executive Director of Hope for Single Mothers with Disabilities, a women-led NGO in Rwanda representing single mothers with disabilities. Hope for Single Mothers actively promotes inclusion and diversity, focussing on the rights and needs of young women and women with disabilities. Winnie holds a Bachelors degree in Monitoring and Evaluation from Makerere University, is an expert in disability advocacy, and a trainer on the United Nations Convention on the Rights of Persons with Disabilities in local communities in Rwanda. Winnie represents HSM on the Feminist Humanitarian Network, and is a member of the FHN's Advocacy Committee.

Mmonbeydo Nadine Joah is a member of the FHN Membership Committee. Mmonbeydo is a lawyer and feminist who believes everyone should have the right to live a life free from violence, and where men and women, boys and girls enjoy equal rights and opportunities and have a say in decisions that affect them. She has a PhD in management science specialising in gender and peacebuilding from Durban, South Africa, an MA in International Relations from the catholic university of the sacred heart of Milan, Italy, and an MA in Peace and conflict studies from the European Peace University, Austria. Irene has in the last ten years worked on widening the civic space, participation and representation of women and youth in Uganda and Africa at large.

At National level she worked with the Family Planning Association to ensure the Tanzanian Court of Appeal upholds the landmark 2016 ruling by the High Court against child marriage and the establishment of weekend Youth Friendly Services for district health centres.



## **Jacqueline Hart**
